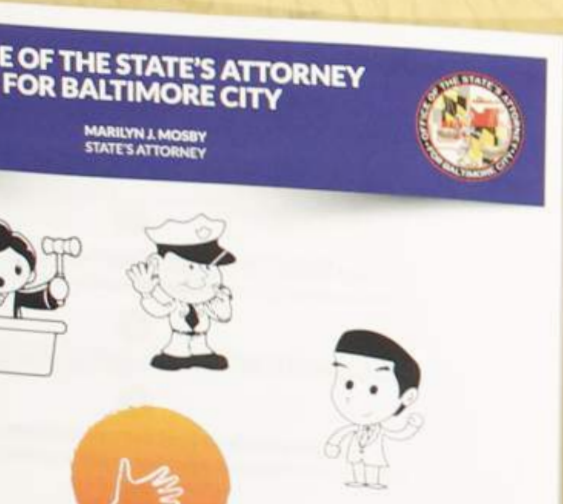








# WHY GIVE

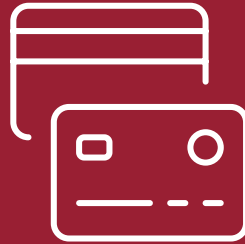


# VICTIMS' EMERGENCY FUND

The Victims' Emergency Fund (VEF) is the only fund for victims in Baltimore City that provides immediate emergency relief. While the Maryland Criminal Injuries Compensation Board provides financial assistance to cover major expenses such as funeral bills and lost wages, not all losses are covered. To help fill this gap, the BCSAO maintains the VEF. The VEF is available for families of homicide victims, as well as victims of robbery, sexual assault, domestic violence, and child abuse. Managed by the Victim & Witness Services Unit of the BCSAO and funded solely through donations, the VEF provides emergency relief to help victims regain any financial losses and empowers them to mentally, physically, and emotionally recover from their encounter with crime.



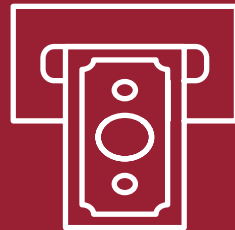

### **WHAT DOES THE VEF SUPPORT?**

Every day, the BCSAO Victim & Witness Services Unit receives calls from individuals who due to no fault of their own are impacted physically, emotionally, and financially as a result of criminal activity. Many do not have the means to recover from their losses. The VEF supports everything from paying the cost to replace robbery victims' state-issued identification to covering prescription drug costs for a sexual assault victim who does not have medical insurance. Vital to empowering victims of crimes to move past their tragic encounter with crime toward a future of hope, the VEF, also supports victim travel, utility, insurance deductibles, housing and food expenses.



## WINTER SOLSTICE BENEFIT

In 2015, the BCSAO hosted its first Annual Winter Solstice benefiting the VEF. Since then, over 1,000 attendees have gathered to not only eat, drink and celebrate dedicated prosecutors and support staff within the BCSAO, but to also commend community members that work to improve the Baltimore criminal justice system. Proceeds from the event go to the VEF. During the first term of the Mosby administration, Winter Solstice raised over \$85,000 for the VEF. This year the BCSAO will host its 5th Annual Winter Solstice Benefit on December 19, 2019 at the Grand Baltimore.

## VICTIMS' EMERGENCY FUND RUN/WALK

In 2016, the BCSAO reinstated the popular Victims' Emergency Fund Run/Walk to support the victims and witnesses of crime in Baltimore. This event is part of the BCSAO's effort to prioritize the needs of victims and witnesses of crimes that occur in Baltimore. Over 200 individuals have braved the elements to race over 3.2 miles through Baltimore to raise over \$20,000 to benefit victims and witnesses of crime. The BCSAO will continue the tradition on September 7, 2019 at Rash Field.

# COMMUNITY FUND

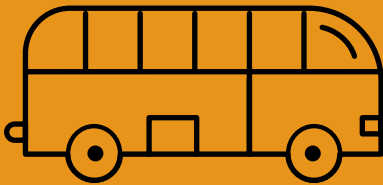

In order to reach these goals, the BCSAO is taking a holistic approach to fighting crime, educating, engaging and empowering Baltimore's communities through the Community Engagement Unit, and making significant investments in our youth through the Crime Control and Prevention Unit. The BCSAO established the Community Fund to support these efforts, many of which are only possible through the support of grant funding, sponsorships and donations.

### **WHAT DOES THE COMMUNITY FUND SUPPORT?**

The Community Fund is critical to achieving the BCSAO's mission to rebuild trust in the criminal justice system. Whether it be offering student field trips to the Supreme Court for our Junior State's Attorneys or a Night at the Zoo during our B'More Pop-Up Series, the Community Fund supports the BCSAO's efforts to positively engage youth before they run the risk of getting entangled in the criminal justice system. The Community Fund also provides the BCSAO with the tools and resources to offer community forums and second chance opportunities to first time non-violent felony offenders through the AIM to B'More program, including financial assistance for participants' employee union dues, professional attire and training courses.



## COMMUNITY ENGAGEMENT

In 2015, State's Attorney Mosby created the Community Engagement Unit and tasked the unit with educating, engaging and empowering Baltimore's communities. Today, Community Engagement is led by a director and includes nine community liaisons each assigned to a police district. The liaisons keep communities informed about key cases and trial dates, facilitate victim and community impact statements and connect victims to resources.

# EACH YEAR

the Community Engagement Unit plans several events designed to connect the community with the BCSAO, including quarterly Community Days in Court and National Night Out. The unit will also look to offer an annual conference on criminal justice reform tackling topics such as mass incarceration, re-entry, diversion and pre-trial detention to build a fair and equitable legal system.

## **COURT IN THE COMMUNITY**

Court in the Community is an event created by State's Attorney Mosby and held quarterly by the Community Engagement Unit with the purpose of educating the public about the criminal justice process.

Initially housed in the courthouse, then transitioned to locations throughout the City, Court in the Community has covered criminal justice topics including recidivism, domestic violence, sexual assault, LGBTQ rights, and juvenile justice. The event typically includes an overview of the court process as it relates to the topic at hand, an interactive panel discussion with subject matter experts, and a question and answer session with State's Attorney Mosby.

## **RESOURCE FAIRS & EVENTS**

You can find BCSAO Community Liaisons at events throughout the City educating Baltimoreans and providing resourceful information for community members to become more actively engaged in the criminal justice system. Community liaisons value understanding the needs of the community and attend various community events to identify and address the public safety concerns that plague Baltimore's residents.



## CRIME CONTROL AND PREVENTION

Under the Mosby Administration, the BCSAO has made youth programming a priority through the Crime Control and Prevention (CCP) Unit by developing programs that introduce the city's youth to the positive aspects of the criminal justice system. The BCSAO not only prosecutes those who commit crimes in Baltimore City, but also plays an active role in the prevention of crime by getting to youth before they run the risk of getting entangled in the criminal justice system.



### **JUNIOR STATE'S ATTORNEY PROGRAM**

A six-week summer intensive for current and rising ninth-grade Baltimore City students. Rising ninth grade students are exposed to careers in the field of criminal justice spending the summer meeting with judges, prosecutors, police officers, forensic experts, elected officials and more. The summer concludes with a mock trial presentation at the University of Baltimore before sitting Baltimore City judges, friends and family.

### **GREAT EXPECTATIONS**

A ten-month program that introduces fourth grade Baltimore City Public School students to careers in the criminal justice system. Since the program's inception, the BCSAO has exposed close to 500 fourth and fifth graders to positive careers in the criminal justice system.

### **PROJECT 17**

Launched by the BCSAO in 2017 for students at Frederick Douglass and Renaissance Academy high schools, Project 17 provides monthly workshops and resources to help students achieve academic excellence, reduce truancy, and earn practical work experience.

### **#B'MORE POP-UP SERIES**

Free summer programming available to youth and their families during the critical evening hours of 6 p.m. to 9 p.m. on Fridays when juvenile crime is most likely to occur. Since the launch of the Pop-Up series, the BCSAO has served over 5,000 youth and their families.

### **AIM TO B'MORE**

An alternative to incarceration for first-time low-level felony drug offenders. Successful participants graduate without a criminal record and with a career.
